#### LEGAL EXPERIENCE

I oversee motion practice and discovery to certify the matters for trial.

Associate Judge, Second Municipal District, Skokie, Illinois: October, 2021, through July 17, 2023

While I was primarily assigned to traffic and misdemeanor cases, I also handled civil matters, preliminary hearings, bond hearings, domestic violence matters including civil orders of protection, officiated weddings and oversaw the issuance of arrest and search warrants. My calls were voluminous and several of the litigants were self-represented.

# **Associate Judge, First Municipal District, Traffic Division:** January 6, 2020 through October 2021

Handled high volume traffic calls and misdemeanor DUI cases. During the pandemic, I was among the first judges to conduct court calls exclusively on Zoom. We managed enormous dockets on line as the courts had been closed for over 90 days and the backlog needed to be addressed.
